3 Shipment Definition

A shipment is the sum of all packages which are send <u>on one day from one plant to one consignee</u>. It may happen that the supplier receives multiple orders for several parts but for the same receiving plant and delivery date. These orders have to be consolidated to one shipment.

4 Company Names of the Mubea Group and Assignment to the Company

Due to different company names within the Mubea Group a faultless addressing of delivery notes and transport documents has to be guaranteed. The same applies for transport ordering. Each Mubea purchase order advices the receiving plant and invoice address. Due to multiple company names a correct assignment to company, plant and legal form is essential.

5 Mode of Transport

Along the existing delivery schedules and single orders, EXW and FCA shipments have to be handled as follows:



5.1 Parcel up to 32 kg

Parcel and shipments up to 32 kgs have to be sent via UPS (Standard Service). Fix time deliveries are just possible upon agreement with the Mubea purchasing department. For non-authorized fix time deliveries Mubea reserves the right to debit back the freight costs to supplier. Please note that for shipments at the expense of Mubea, the supplier needs an account number as well. For dispatch handling you may use all existing UPS-Tools (Worldship etc.), the Internet (<u>www.ups.com</u>) as well as the Service-No. +49 1805 882663. Please note that deliveries to Mubea require the following information:

- Entering of the complete Mubea order number as reference no.
- Correct shipping option: "Bill the Receiver"

6 Shipment Advice

The shipment advice is only possible with a specified access. Fax or e-mails are not accepted.

6.1.1 Required Information on the Shipment Advice

The notification of the readiness for dispatch has to contain the following information:

- Mubea Order-No.
- Loading times
- Receiving plant incl. delivery date according to Mubea-order
- Number of packages, weight and dimensions
- Packaging code and stack ability

6.1.2 Advice Times

Generally the shipment advice has to take place on day A (up to 3.000 kgs until 2 p.m., over 3.000 kgs until noon). The pick-up is on day B. Within Germany the delivery is on day D. Austria and Switzerland is on day F. For European suppliers the transit times may vary between three and seven days. Please contact the 4PL Sostmeier for more information.



6.1.3 Non-EU shipments

Please not that sender for deliveries to Non-European countries is responsible for the complete and correct customs declaration and export paperwork.

6.2 Shipment Documentation

Besides the delivery note, which has to be fixed safely on the packages, it is mandatory to hand over a transport document (freight order) to the driver at collection or an UPS-freight order/ -label for a shipment until 32 kgs. Customs paperwork (invoice, packing list and MRN) have to be handed over to the driver in a separate envelope.

Our purchase order is mandatory for the order entry and needs to be stated in all delivery documents (delivery note and freight order as well as UPS-freight order).



6.3 Transport of Machines and Equipment

In case of oversized machine and equipment transports this routing order does not apply. These kind of transports have to be coordinated with our central logistics department.

7 Free Domicile Deliveries

Please consider the instructions as recommendation in case we agreed "free domicile / DAP" terms. Billing of transport costs on the supplier's invoice is generally not accepted.

8 Expedites

Expedited transports ordered by the supplier at the expense of a Mubea plant will not be paid.
