# Health, Safety and Environment (HSE)

It is our stern ambition to avoid any negative impact of our business activities on man and environment.

## **ENVIRONMENTAL PROTECTION**

We strive to use natural resources responsibly by minimizing our environmental footprint in daily work.

Climate change is evident already today and poses a very serious threat to the future of planet earth. In order to limit negative impacts substantial steps towards  $CO_2$ -neutrality are imperative.

Mubea therefore commits to continuously reduce climatedamaging emissions with the aim to match  $CO_2$ -neutrality. Making our products and processes sustainable and substantially reducing our  $CO_2$ -footprint are thus strategic goals. In order to do so, we intend not only to procure energy efficient products and services and to improve energy efficiency, but also gradually increase the use of renewable sources of energy. Beyond that, as a lightweight specialist, Mubea makes a major contribution to reduce emissions during the use phase of our customers' products.

We recognize appropriate resource management as an essential prerequisite for sustainable production. Employees need to fully adhere to the HSE guidelines and we expect colleagues to make each other aware of unsafe behavior.

#### **CONTINUOUS IMPROVEMENT**

We continuously drive improvement in our HSE management systems and performance. The management sets annual objectives and targets and regularly measures performance against them. It is responsible to provide the required resources. We are calling on all employees to participate actively in further developing our HSE system. Employees are encouraged to propose specific improvement ideas and are expected to take early action if deviations occur.

We prepare and practice for emergencies and draw the lessons learned from accidents and events. These are used to raise and improve our standards and are communicated to prevent recurrence.
